Board Reports

President - Michelle Benoit

• Welcome to Emily Price, ETS advisor at Southwestern Oregon CC, who stepped in to fill the role of District 4 Rep! Policy Seminar was successful despite being virtual this year. We met with staffers from all seven Oregon Members of Congress and they were receptive to our asks. We held two OTA member forums on Zoom to share concerns and resources related to serving students virtually. 30 members attended the collegiate-level forum and 32 attended the pre-college forum. We will hold two additional forums in the coming weeks. Matt created a Google doc for OTA members to share resources. With the conferences being canceled, we will focus our efforts on the strategic plan goals that were updated last August under Roseann's leadership.

Virtual Policy Seminar

- 700 TRIO professionals and alumni participating
- 225 virtual meetings held with House and Senate offices
- Stay in contact with their Congressional offices about the fourth COVID-19 stimulus recovery bill.

The CARES Act was signed into law on March 27

Includes \$12.5 billion to colleges, based mostly on their share of students with Pell grants.

- At \$6.25 billion for direct emergency aid to students, including "grants to students for food, housing, course materials, technology, health care, and child care."
- Colleges can use up to \$6.25 billion broadly to "defray expenses for institutions of higher education."

We are asking Congress to:

- Provide \$250 million to increase TRIO capacity by 15% across all TRIO programs, translating into serving an additional 330,000 low-income, first-generation students, students with disabilities, veterans, and unemployed adults. This includes a request for \$32 million for EOC to increase program capacity by 50% and \$54 million for the Talent Search program to increase capacity by 25%.
- Provide \$200 million immediately to all TRIO programs for technology and Internet so students can complete coursework online and connect to support staff; and
- Tighten broad waiver language in the COVID-19 Phase 3 legislation Congress passed last week, to prevent repurposing TRIO funds.
